

Where Are We Today?

The board of directors spent time during the last annual meeting discussing this question – *where are we today?*They took a deeper look into how WVICU has changed over the years, the success of the Circle of Vision scholarship program, and how our students compare to those in the public sector. There is value in what our member institutions provide for their students and we believe this is a message worth sharing.

LEADERSHIP STRUCTURE

In 2010 there were 17 corporate board members, 8 institutional board members, a part time director, and a full time administrative assistant. A shift came a few years later when the board was reduced to 7 corporate members plus the institutional members. In 2019 the board moved away from having staff and executed a management contract with Three Point Strategies, LLC. Currently, the board consists of 7 corporate and 7 institutional members.

CIRCLE OF VISION (COV)

Fundraising has always been a priority of WVICU. After several years of more than \$500,000 in annual gifts, the COV scholarship program experienced a significant decline in donations. In 2019 we initiated a marketing campaign increasing our exposure on social media and ramping up our fundraising efforts, resulting in a 14% increase over the last four years. Since its inception, the COV has raised over \$8 million dollars and provided financial support to more than 3,500 students. This has only been possible because of the generous support of our donors.

STUDENTS

There is a common misconception that private higher education is too expensive and/or only serves wealthier students; this is simply not true. According to the Integrated Postsecondary Education Data System (IPEDS), data shows 38% of the students attending a West Virginia public 4-year institution are pell-eligible and 41% of the students attending a private non-profit institution are pell-eligible (average over five years). Not only does WVICU serve a greater percentage of pell-eligible students but are also graduating students at a higher rate. Last academic year, the pell-eligible 6 - year grad rate was 47% for private institutions and 35% for public. Many of our students graduate early, which means they enter the workforce much faster and can begin earning an income. WVICU students on average earn \$5,620 more and have a debt-to-income ratio that is 3% less than those from the public schools.

It's clear that the WVICU member institutions matter and even more so, the students matter. Our mission is to provide a personal and diverse educational experience, responding quickly to student and societal needs, increasing student successes, and engaging the future of West Virginia.

Thank you for supporting the WVICU and the Circle of Vision scholarship program. Our achievements are not possible without your partnership.



The **Circle of Vision Scholarship** program was started in 1997 and provides West Virginia students with the opportunity to attend one of our seven private colleges or universities. Many of these scholars are the first in their family to attend college.

WVICU colleges and universities do not receive state government funding. We depend on corporate, foundation, and private partnerships to help make college more affordable for West Virginia students.

Since 1997, Circle of Vision scholarships have been awarded to 3,500 students totaling nearly \$8,000,000.

During the 2022-2023 academic year, the Circle of Vision Scholarship Program assisted nearly **100** students who demonstrated financial need and academic excellence with the total giving of **\$459,650** distributed among all member institutions.



We Serve 7000 Students

WVICU institutions serve 7,000 students including over 2,700 West Virginia residents. Nearly 2,000 are first-generation college students.



We Belong \$275 Million

The total estimated annual economic impact of WVICU members is \$275 million.



We Achieve +18% Grade Rate

The average four-year graduation rate at WVICU institutions is 18% higher than WV's public institutions; and the six-year graduation rate is 12% higher.

WVICU established the **Legacy Endowment Scholarship Fund** in 2010. By contributing to this fund, you can make a permanent and positive difference in the lives of deserving West Virginia college students through planned or current giving. Bequests from generous West Virginians helped establish this fund, which awards scholarships annually to West Virginia students at member colleges and universities through the Circle of Vision Scholarship Program.

Several large donations from individuals who believe in private higher education were combined to create this fund. Many others have contributed to the fund over time. The Legacy Fund has contributed a total of \$140,000 to the Circle of Vision Scholarship Program over the last seven academic years.





Economic Impact Eport Report ACADEMIC YEAR 2021-2022 This program/project has been funded through a Capacity-Building Grant from the Council of Independent Colleges (CIC).

The West Virginia Independent Colleges and Universities (WVICU) has been championing independent higher education throughout the state for over 70 years.

In 2022, an independent research study was conducted to determine the economic contributions of the member institutions of the WVICU to the West Virginia economy.

Methodology

Using financial information and institutional data from fiscal year 2021/2022 provided by each member institution and the IMPLAN* economic impact modeling system*, economic impact models were estimated for West Virginia and for seven regional economies within the state. These models were used to quantify the economic contributions that these institutions collectively make to the state and to their respective regional economies.

*The IMPLAN® economic impact modeling system is a product of Minnesota IMPLAN Group, Inc. (www.implan.com).

Impact Summary 2021/2022

Member institutions of WVICU enrolled nearly **7,000 students** with **1,426 employees**. Total annual payroll compensation is approximately **\$67,384,915.00**.

Direct, Indirect & Induced Impact

The direct impact calculated for all WVICU member institutions totals \$158,105,190.00. An estimated \$69,342,852.59 will also be created throughout the state as a result of indirect industry-specific spending within each region. An additional \$47,113,163.23 is estimated to stem from induced income from students, household labor income, and related spending in the supply chain for goods and services.

Direct, indirect, and induced impacts are totaled together to calculate the total estimated economic impact by WVICU members on West Virginia's economy.




